Ranchos Citizens' Water Group Takes First Steps

In early March, a group of approximately 30 concerned Ranchos citizens met at the Ranchos Pizza Factory and began the process of giving the Ranchos a voice in Madera County water decisions.

"The train is leaving the station," said Igal Treibatch, Ranchos property owner and grower. "The only way we can get into projects [affecting Ranchos water] is to be a part of the Integrated Regional Water Management Plan."

The state of California has decided that all future decisions regarding the use and management of water throughout the state have to be integrated with every other part of the state. Treibatch explained that the days of Los Angeles doing one thing and Fresno doing another while Sacramento does a third are gone. Projects that impact water use throughout the state are being created but only entities that are recognized as "signatories" to a Memorandum of Intent (MOI) with the Integrated Regional Water Management Plan (IRWMP) will be allowed to access the system.

"It is the only way we can get money for projects and have a say in the process," Treibatch said.

Some Background

In September 2008, SB 1 was signed by Governor Schwarzenegger, containing the "Integrated Regional Water Management Planning Act." Effective March 1, 2009, the California Department of Water Resources established the Region Acceptance Process, creating guidelines used to evaluate and accept a region into the IRWMP grant program.

According to www.irwmp.org, the state has innovated, "... a system that presents an opportunity for a voluntary, non-regulatory

planning process that both encourages and truly protects good faith efforts toward meaningful change and improvements that will benefit local communities, regions and the state as a whole. To top it off, there is a built in reward system (eligibility for state funding) only for those who follow the rules."

Part of the objective of the Ranchos group was to achieve non-profit status in order to go forward with the group. At the meeting, community member Jan DeWoody revealed that such a non-profit corporation already existed and that it could be applied to the needs of the newly forming water group. Called the "41 Corridor Alliance," this 501(c)(3) non-profit was structured

broadly enough to allow for the inclusion of other projects, such as an IRWMP organization.

On Monday, March 15 the group met again for the purpose of establishing by-laws for the organization and giving it a degree of structure.

The organization is open to all members of the community who would like to have some say in the future of water decisions for the Ranchos. "It's important for the group here, which has one of the worst overdraft problems, to be represented," Treibatch said.

Mosquitoes About to Bite Ranchos

According to Ken Klemme, Biologist for the Madera County Mosquito & Vector Control District, it appears that this is going to be a wet year and Madera County Mosquito & Vector Control District technicians have started spraying standing water as of March 15. Klemme said that the Department has also started taking dead bird calls as of March 15.

"I would like to remind the residents that they should call 1-800-WNV-BIRD if they have a fresh dead bird on their property so that we can test for West Nile Virus," Klemme said. "We should have mosquito fish available for pick up April 1. Please call first to ensure the availability so that we can accommo-



date your order. We also offer free delivery of fish if you are within our district boundary."

Klemme said that if you notice a green swimming pool to please let them know.

Klemme's Department handles swimming pool calls with anonymity, ensuring that your neighbor will not get in trouble. "What we do is for the greater good," Klemme said.

Of utmost importance is if you notice more mosquitoes than usual you can always call the main office of the Madera County Mosquito & Vector Control District at 674-6729, or you can use the website at www.maderamosq.org to place a service request.

Animal Shelter Fights for Life

Animal shelters everywhere are struggling with budget cuts, reviewing their options and are vowing to find ways to avoid increased and wholesale euthanasia of homeless animals entrusted to their care. The Madera Animal Shelter is still reeling from recent and drastic cutbacks. But there is a surprisingly simple and inexpensive way the public can help right this wrong, according to shelter director Kirsten Gross.

"All dog owners need to step up, comply with the law, and license their animals," said Gross. The current county licensing fee is \$8 for altered dogs and \$16 for unaltered dogs. Full compliance with the licensing law could contribute as much as a million dollars to the shelter and fully fund the shelters operation, according to Gross.

Bigelow Attends Washington, D.C. Legislative Conference

The conference, held March 6-10, featured remarks from House Speaker Nancy Pelosi and President Obama cabinet secretaries Kathleen Sibelius and Tom Vilsak.

One of the main objectives of the Legislative Conference was to bring county officials face-to-face with federal government officials to discuss key county government priorities and specific legislation, regulations and funding levels affecting essential services and

"In addition to serving on these committees, I had a wonderful opportunity to network with County officials from across our great country that provide additional insight for today's challenges."

Jobs, economic recovery and Restoring the Partnership were the main themes of the conference for more than 2,000 elected and appointed county officials from around the country. Featured guest speakers included House Speaker Pelosi, Health and Human Services Secretary Kathleen Sebelius, Agriculture Secretary Tom Vilsack, Rep. Gerry Connolly (D-Va.) and TIME magazine columnist Joe Klein. "NACo's 2010 Legislative Conference was a tremendous success," said NACo President Valerie Brown, supervisor, Sonoma County, Calif. "Our members are fiercely committed to Restore the Partnership between the federal government and America's counties and this conference went a long way toward that goal."

Grand Jury Report Special*

First my thanks to all on the Grand Jury. I thank you for unselfish service to our community. I also thank you for now posting your reports on line.

Now my soap box: To deal with an official Grand Jury Report as an item on the Consent Calendar is an insult to the Grand Jury and to the public they are representing. This Report is dealing with Madera County Fire Station number 8, also known as Indian Lakes Fire Station, also known as the Casino Station, also known as the Chukchansi Fire Station.

I urge you to go on line and read this and other reports by going to www.maderagrandjury.org. On the left side of the page click on "Grand Jury Reports."

What follows will be Grand Jury recommendations followed by D.O.G. comments, opinions or clarifications.

Recommendation 1: The station's emergency power system should be expanded to include the fire crew's living quarters.

D.O.G.: This station has a lot of history behind it. It was designed and built with many fingers in the pie. This is one of the many County projects deserving of the description "STUMBLE, BUMBLE & FLUSH." First they stumble right past good planning, bumble the execution of the contracts and construction and inevitably flush many of our tax dollars down the drain.

The station's emergency power system is not something that should need expanding. The emergency generator is in the system. It doesn't take a rocket scientist to figure out that if you have a facility with emergency backup it should include a couple of plugs for the fridge, freezer, dispatch radio and a couple of lights in the living quarters for the staff.

Unfortunately this was only a small glitch of many in the construction of the station.

Recommendation 2: The funding, staffing and equipment needs for the station should be reviewed. At the earliest opportunity, the Memorandum of Understanding (MOU) with the Tribe should be amended to reflect the new personnel and equipment requirements resulting from the Casino enlargement.

D.O.G.: This is a classic "S.B.&F." but of a different color. As is the case with many agreements or MOUs the County "negotiates," the other party gets the elevator and the taxpayers get the shaft. First our "negotiators stumble in, then our County Counsel bumbles the review of the ramifications of provisions in the document, then (yes, you guessed it) our tax dollars get flushed. We don't have a requirement to require anything: there is no provision for expansion for either the new tower or anything added in the future.

Recommendation 3: Madera County Board of Supervisors should re-evaluate potential county liability with respect to the Memorandum of Understanding.

The Board of Supervisors' response to Recommendation 3? "County Counsel and County Risk Management were asked to advise our office on this issue of liability. Based on their research, the liability to provide fire protection does not lie with the County. Government Code Section 850 states, 'Neither a public entity nor a public employee is liable for failure to establish a fire department or otherwise to provide fire pro-

I will continue to serve you, not as your full time supervisor, but as your OVERTIME supervisor because that's what this job has always demanded from someone who truly cares.



Editorial

Just Stand Up!

Sometimes the answer to vexing questions just seem so obvious you wonder why those mired up to their hips in the midst of their problem can't just stop, look around and then say, "Oh yeah ... I see now."

One of the first examples that comes to mind is how every year during the summer up at Avocado Lake in Fresno County there is invariably an adult who drowns. As sad as that statistic is, what's more disturbing is that usually the adult drowns in about 3 feet of water. My good friend pointed out that unless the adult is 2 foot 11, here's a suggestion: Stand up! If you're 4 feet tall and you're at Avocado Lake and you discover you're under three feet of water and it's getting hard to breathe, stand up! Your head will be a foot above the water that's trying to drown you.

Just stand up!

There's a movement afoot across the land that suggests that Barack Obama wasn't actually born in Hawaii, as he claims, therefore making him not native born and ineligible to be president of the United States. 

Adopt-a-Book Program



Book Recommendations


Young Adult Fiction: *The Tree Shepherd's Daughter* by Gillian Summers. For 15 years Keelie Heartwood was raised solely by her high-powered attorney mom, in the swanky part of L.A. until her mom's sudden death sends her to Colorado and her long-lost father's world of traveling renaissance festivals. Miserable and feeling totally out of place, Keelie makes plans to split until she begins to notice that she has something in common with some of the festival dwellers: pointed ears. Well, Keelie actually only has one pointed ear. The other is normal, indicating a mixed marriage on her parents' part. This delightful story includes fairies, sprites, bhata and other assorted non-human folk. Teens and adults both will enjoy this lighthearted fantasy land.

Adult Fiction: *Into the Wilderness* by Sara Donati. Fans of Dianna Gabaldon's *Outlander* series will appreciate the care and detail of this excellent story set in upstate New York during the same time period as Gabaldon's. In fact, several of her characters, including Claire



Fraser and Ian Murray, are mentioned in passing when talk turns to the war with the British. But this story begins with Elizabeth Middleton, considered a spinster at 29, arriving in America to teach school in the wilderness town of Paradise in upstate New York where her father has lived for many years. Unknown to Elizabeth, however, is her father's plan to marry her off to the town doctor in order to settle his debts. Strong-willed but with a genuine heart for nature and indigenous people, Elizabeth becomes known as "Bone-in-her-Back" by the Mohawks as she quickly gains their respect. She also falls in love with Nathaniel Bonner — the absolute wrong choice according to her father. For historical romance buffs this is a book to cherish. The characters are well-defined and the plot has enough twists to make it a memorable tale.

Check out these books and more at the Ranchos Library and don't forget your library card – don't leave home without it!







has already been hit hard with reductions and most of the looming and further budget cut options are severe, and more unpalatable. The reality is the homeless animal population will suffer and, unwanted, the dogs and cats will likely pay the ultimate price for human fiscal irresponsibility.

Shelter volunteers had recently celebrated increasing their “save rate” for shelter animals adopted or sent to outside rescue groups from 28 to 35 percent, a small, hard-won increase now unlikely to be sustained.

Shelter Hit Hard with Layoffs

Gross said starting March 1, 2010, the animals at the Madera County Animal Shelter will have a quarter less staff – five less employees to take care of the same number of animals.

“Three positions were eliminated and two employees took the retirement option. These staff reductions are a direct result of the fiscal crisis that the County of Madera is facing, reportedly as large of a shortage of at least \$4.9 million,” Gross said.

The Animal Services Department has been asked to decrease expenditures \$160,000 for the fiscal year 2010/2011. More cuts, and more possible layoffs, are being considered, as the County struggles to narrow the financial gap, according to Gross.

“The loss of these important positions to our department is devastating,” said Gross. “We are expecting a record year of unwanted animals pouring into the shelter; over 10,000 animals this coming year. That’s over 1,000 more than last year. Each of these animals needs care – a place to rest, food, water and more. These animals need this care seven days a week. We can’t just put them on the shelf and deal with it another day.”

More Service Reductions To the Public

The public will see a further reduction in animal control services as the remaining staff is spread even thinner and the department struggles to continue providing services to the community and care for more of its homeless animals. The shelter has already closed its doors to the public for administrative services two Fridays a month and has reduced service and telephone hours.

“Since our really busy season is just around the corner – over 1,000 animals each month impounded during the months of March, April, May, and June – we are truly concerned that we can provide the necessary care and services for such an overabundance of unwanted animals,”

Gross said. “Caring for these innocent animals is our first priority. We will respond to emergencies as quickly as possible and general animal services requests will be addressed as we can get to them. We are also asking that the public be patient with us, as we attempt to adjust to these catastrophic cut backs.”

Less animal control staff will be available to protect the public from vicious dogs running at large and respond to other animal emergencies in the community, according to Gross. Animal Control officers often respond to injured animals along roadsides and cases of alleged animal cruelty.

Increasing Dog Licensing Only Option Left

Gross said the dog population was estimated at a minimum of 75,000 dogs in Madera County and that dog licensing compliance was extremely low, estimating less than 5 per cent of those dogs were licensed and properly vaccinated.

“If the majority of these dogs had their rabies vaccines and were licensed – as required by law – the revenue would provide all the funding needed to run the entire Animal Services Department with a full complement of staff, which is approximately \$1 million annually,” gross said. “If the Animal Services Department can find additional revenue, we can get some of our employees back and bring our service levels back to more acceptable levels. The department



is therefore launching a campaign to get more rabies vaccine and dog licensing compliance in the community.”

According to Gross, licensing and other fees were in the process of being reviewed and will likely be increased in the near future. Animal control officers have also been writing more tickets and issuing fewer warnings about failure to license as in the past. Citations for an unlicensed and unvaccinated dog start at \$78 for a first offense and can go as high \$150 with court costs.

Gross said humans contacting the deadly rabies virus is the main concern behind the legal vaccination requirement. The rabies virus is mainly spread through saliva from animal bites, and sometimes scratches that break the skin.

“Rabies is a disease that is fatal to humans and other susceptible animals,” gross said. “Rabies vaccines protect your pets and our community. It is one of the few diseases than can spread from animals to people with deadly effects. Vaccinating your pets will protect your pet, your family and the community. Rabies vaccines are also required by law for all dogs over four months of age. Animal Services also recommends rabies vaccines for cats. However, there is no legal requirement for cats to have rabies vaccines yet.”

Licensing Your Dog Helps Other Homeless Animals

Not only does getting your dog licensed support the animal shelter, it has other benefits to the dog owner. The rabies vaccine is \$6 and protects your dog, your family and the community from this deadly disease. Licensing the pet will keep pet owners in compliance with the law. Non-compliance can result in citations, fines, court costs and hundreds of dollars in added fines and expenses. A pet

wearing a current license will get a free ride home if picked up by an Animal Services Officer in Madera County.

Dogs must be vaccinated for rabies prior to being licensed and proof of rabies vaccination is required. Gross said if a pet is brought into the shelter wearing a license tag, the owner will be notified and the animal will be held 10 days instead of only three days as with unlicensed strays.

“Licensing can save the life of your pet. Early compliance with rabies vaccines and licensing can prevent costly citations from animal control. It will give your dog a free ride home, will provide him with a longer stay if he ends up at the shelter. The additional revenue from licensing will also directly benefit the shelter operations and the 10,000 homeless pets we are expecting in Madera County in 2010,” said Gross.

Rabies vaccines can only be administered by a licensed veterinarian. Local veterinarians can provide your pet with the required rabies vaccine. Another option would be to attend local low-cost vaccination clinics. The Madera Animal Services Department has partnered with Dr. David Dierberger to provide rabies and other vaccines once a month at the Animal Shelter. Licensing can also be done at the shot clinics Gross said.

The low cost vaccination clinic at the Madera County Animal Services location is held the first Saturday of each month at the animal shelter at 14269 Road 28. The clinics are open to the public from 10 a.m. to noon, with no appointments necessary. The rabies vaccine is \$6 and all other shots are available at a reduced rate.

Licensing in the county is \$8 per year for altered dogs and \$16 for unaltered dogs. The rates for seniors over 65 years of age are \$4 for altered pets and \$8 for unaltered pets. For any other questions regarding the low cost vaccination clinics, please call 675-7891.

Smiling Faces Often Hide the Truth

“When they brought the colt to Jesus and threw their cloaks over it, He sat on it. Many people spread their cloaks on the road, while others spread branches they had cut in the fields. Those who went ahead and those who followed shouted, ‘Hosanna!’ ‘Blessed is He who comes in the name of the Lord!’ ‘Blessed is the coming kingdom of our father David!’ ‘Hosanna in the highest!’ Jesus entered Jerusalem and went to the temple.” (Mark 11:7-11)

Palm Sunday, the Sunday prior to Easter Sunday, is sometimes looked at like a celebration. In many churches

But in a short time, these same folks were going to hand Him

Jesus is crucified somewhere every day. Palm Sunday is a scandal. Palm Sunday is a day when human nature is shown to be untrustworthy. Palm Sunday is an attempt to make a bloody crucifixion look pretty. The magnificent idea of Jesus Christ is that Jesus walks right into the middle of all of our Palm Sundays and He is surrounded by our smiling faces. He knows that we are the one who are going to crucify Him, someday, somehow. But Jesus still shows up.

over to be crucified. They handed an innocent man over to be crucified and no one did anything about it. Where was Peter, always with his big talk? Where were the followers of Jesus? The church has often been absent during times of injustice.

A Golden Oldie

Have you ever heard that 1971 song called “Smiling Faces” by the group “Undisputed Truth”? It is a song about people who smile in your face, but plot against you later. If you can, picture a movie of Jesus coming into Jerusalem with all these smiling faces cheering Him on. Matthew 21:8 describes the situation very well: “A very large crowd spread their cloaks on the road, while others cut branches from the trees and spread them on the road. The crowds that went ahead of Him

and those that followed shouted, ‘Hosanna to the Son of David!’ ‘Blessed is He who comes in the name of the Lord!’ ‘Hosanna in the highest!’” In your mind’s eye of this scene, imagine the song “Smiling Faces” playing in the background: “Smiling faces sometimes pretend to be your friend; smiling faces show no traces of the evil that lurks within. Smiling faces they don’t tell the truth ...”

The people had welcomed Jesus like a hero! They had found someone in Jesus who they thought was going to deliver them from the cruel Roman oppression, deliver them from the arrogance of religious leaders, deliver

them from the greed of political leaders and deliver them from the ravages of cruel poverty and sickness. The people had watched Jesus and they had followed His every word. Everyone loved Jesus when He healed, they loved Jesus when He saved, they loved Jesus when He took on the authorities and they loved Jesus when He reached out to the marginalized. When Jesus came into Jerusalem

they all shouted: “Hosanna to the Son of David! Blessed is the one who comes in the name of the Lord! Hosanna in the highest heaven!”

But then something happened. Soon they wanted him crucified. Was it because He didn’t live up to their expectations? Was it because He didn’t do something they wanted Him to do or was it because they resented something He had done? “Those people” who are smiling at Jesus and patting Him on His back, “those people” shaking His hand, shouting His name and trying to get close to Him, “those people” trying to show Jesus how much they care only to crucify Him later ... “those people” are the heart of every sinner who finds the need for the Savior.

Aunt Jean's Ranchos Recipes

Meatloaf Mania

You know how I love to go on the internet for information. Well, when I went on the internet looking for ideas for this article, believe it or not you can find a recipe for just about any way to cook a meat loaf. I found them made with broken up sliced bread, dried bread crumbs, oatmeal, soda crackers or rice. There are recipes with ground beef, pork, veal, turkey, hot or mild sausage or a mixture of any of them. If your family won't eat their vegetables, have you thought of shredding a carrot or zucchini into your meat loaf, or if you don't

like biting into a piece of cooked onion, how about shredding it? I found a recipe on the internet for meatloaf made with Miracle Whip and then the topping was made with Miracle

Whip. As much as I like Miracle Whip, I don't think I would like it in or on my meatloaf. Years ago I had a girl working for me that made her meatloaf with cubed cheddar cheese in it. So see, as long as you have some ground meat to start with, you can make a meat loaf. I've even got one made with sauerkraut below. Don't wrinkle up your nose just yet – it is yummy. And for as many different ways to make a meatloaf there are almost as many ways to cook it. Most of the recipes I read suggest a 350 degree oven but it can be cooked in a loaf pan, glass or metal cake pan, large pie pan, formed into a loaf on a cookie sheet (make sure it has ridges to hold the drippings) or you can even cook it in

a muffin pan. I think the muffin pan would be fun for kids – it would be just their size.

When we lived in San Francisco during WWII we would go to the meat market for all our meat. They didn't have a butcher department in the grocery store then (or not in the one we shopped in anyway). I remember mama would always buy two pounds of ground beef and one pound ground pork every time she was going to make meatloaf. Like so many of the things she made, meatloaf is not written down anywhere, but I know how she made it.

MAMA'S MEAT LOAF

- 2 pounds ground beef
- 1 pound ground pork
- 1 medium onion chopped
- 2 eggs
- 2 or 3 slices of bread
- Milk
- Salt and Pepper to taste

In large mixing bowl, mix the meats together with the onion and

set aside. In small bowl mix the eggs with a fork and the bread that has been broken into small pieces adding just enough milk to make it moist. Add this mix to the meat and add the salt and pepper. Bake in

a 350 oven for 45 minute to an hour. Let sit in the baking pan for 15 to 20 minutes before slicing.



GVUSD Starts Marketing Campaign for 2010-2011

Did you know that Golden Valley Unified School District is the highest performing K-12 district in Madera County and the second highest K-12 district in Fresno County according to the State API? Golden Valley has an Academic Performance Index of 820 and continues to meet all targets under “No Child Left Behind’s” Adequate Yearly Progress Accountability Measures. Choosing a high quality education is one of the most important decisions we make as parents for our children. Golden Valley Unified also takes that responsibility very seriously. We are welcoming students who are residents of our district and students from outside of our district. We also welcome students of employees who work within the boundaries of Golden Valley.

What is the purpose of a district marketing campaign? - As Golden Valley Unified is preparing the budget for the upcoming 2010-2011 school year, we are once again embarking on a district marketing campaign with the expectation of increasing student enrollment within the district and also promoting our award-winning “district of excellence” within the San Joaquin Valley. The greatest revenue source in the district’s budget is accessed from actual student enrollment and average daily attendance. In 2008-2009 Golden Valley experienced a loss of 88 students which equated to approximately a half million dollar decrease in revenue. In 2009-2010 after a successful mar-

Our district covers approximately 85 square miles bordered by the San Joaquin River on the south, Highway 145 on the north, Highway 41 on the east and Madera Unified School District on the west, encompassing the areas around Children’s Hospital of Central California, Rolling Hills, Madera Ranchos, Bonadelle Ranchos and Triego. We have two elementary schools, one middle school, one high school and five alternative educational programs offering independent study, continuation high school, community day school and adult education classes. To enroll a child in Golden Valley under the Employment Based Residence Law (CA Ed Code 48204), parents/guardians are simply asked to present a current paycheck stub or business license to the Education Services Department at the GVUSD District Office; 559-645-7500. Parents/guardians will need the following documents to enroll their student at the new school:

- Child’s birth certificate
- Child’s immunization records
- PG & E bill or renter’s agreement to establish a home mailing address.

Once enrolled in GVUSD, parents/guardians must present annual proof of employment within the district’s boundaries. While some GVUSD classes may be at enrollment capacity, Educational Services staff will work with families to enroll the students where there is space available.

Golden Valley School Bonds Fund Construction Projects

Construction is underway at Liberty High School on a new science building and build-out of the athletic stadium. Harris Construction Company Inc., the Developer, is managing construction of the projects. Site work began in late December of 2009. Concrete footings have been poured for the science building and underground utilities are complete. The concrete slab was scheduled to be poured on Monday, March 15 and wall framing should begin soon after.

The home side bleachers in the athletic stadium have been temporarily moved onto the football field and will be reinstalled as permanent visitor bleachers once the earthwork is complete on the east side of the football field. There will be new home side bleachers with a seating capacity of 1858 and a new press box placed on the west side of the football field just outside the track that is being expanded to eight lanes. Completion of the stadium will also consist of a larger paved parking lot south of the stadium, relocating the scoreboard and construction of a new concession building with men’s and women’s restrooms, ticket booth and equipment storage.

Despite the extremely active wet winter, construction on the science building should and the stadium is anticipated to be complete in early fall in time for the 2010-2011 Liberty High School Football season.

Everyday Technology Safety Tips

Note: We received this from reader Eileen Tiso and thinks it's some great, helpful advice that we non-criminals just don't think about. Editor

GPS -- A couple of weeks ago a friend told me that someone she knew had their car broken into while they were at a football game. Their car was parked on the green which was adjacent to the football stadium and specially allotted to football fans. Things stolen from the car included a garage door remote control, some money and a GPS which had been prominently mounted on the dashboard.

When the victims got home, they found that their house had been ransacked and just about everything worth anything had been stolen. The thieves had used the GPS to guide them to the house. They then used the garage remote control to open the garage door and gain entry to the house. The thieves knew the owners were at the football game, they knew what time the game was scheduled to finish and so they knew how much time they had to clean out the house. It would appear that they had brought a truck to empty the house of its contents.

Something to consider if you have a GPS - don't put your home address in it. Put a nearby address (like a store or gas station) so you can still find your way home if you need to, but no one else would know where

you live if your GPS were stolen.

MOBILE PHONES -- I never thought of this. This lady has now changed her habit of how she lists her names on her mobile phone after her handbag was stolen. Her handbag, which contained her cell phone, credit card, wallet, etc., was stolen. Twenty minutes later when she called her hubby, from a pay phone telling him what had happened, hubby says, "I received your text asking about our pin number and I've replied a little while ago." When they rushed down to the bank, the bank staff told them all the money was already withdrawn. tection service.’”

D.O.G.: Keep in mind that this is the same County Counsel that approved the agreement in the first place. I agree the county is not required to provide fire protection and certainly not required to provide fire protection to a separate and sovereign nation. Where we will get into trouble is we have signed an MOU in return for certain specific considerations; we have agreed to provide essential services.

Let's go outside the narrow realm of point/counterpoint lawyers love, and look at the court of public opinion from which the pool of jurors at any wrongful death trial would come.

Madera County has contracted with the tribe to provide essential services to their facility. If the worst were to happen and a major fire or explosion were to happen, how can we possibly defend our county's actions? What we have is a casino covering tens of thousands of square feet, a hotel tower complex six or eight stories high and what does our county have in place to protect the hundreds – at times thousands – of visitors to the casino?

We have one aging ladder truck, formerly retired, from another department someplace back East (as in it has seen better days), only tall enough to reach the second or third floor and only from a couple of locations around the building.

We also have a quick attack/light engine (basically a big pickup with a small water tank and pump mounted on it.) assigned to the station.

Can you say “worthless toy”?

Now as for the staffing: We have two people. Not two per engine – we have two total. As backup we have the Yosemite Lakes Park Volunteer Company and the Coarsegold Volunteer company. The nearest paid backup comes as one paid staff on the Oakhurst engine (if it isn't on a call to Ahwahnee) or the next staffed engine comes

from the Children's Hospital station on Avenue 11.

How would you, as a family member, respond to County Counsel's assertions we are not responsible for the deaths of your loved ones?

Recommendation 4: Equipment allocations, especially of engines, should be reviewed to reflect the need to support a high-rise hotel, casino and theater and parking structure unique in the county.

D.O.G.: SEE ABOVE

Recommendation 5: The station should have direct, two-way contact with all elements of the emergency response system.

D.O.G.: The answer to this one is a bit complicated. The Board's response is the system is fine. If you only consider land lines they are not all that far off the point BUT when you throw cell phones into the mix it goes to pot. Cell phone 911 calls go to the California Highway Patrol, which has been notorious for its extremely slow response in transferring calls or passing along information to the appropriate agency.

Something the Grand Jury missed completely is the fact that Madera County Board of Supervisors illegally diverted, misappropriated, ripped off – call it what you will – over a million dollars from the County Fire mitigation fund to pay for Station 8. The law allowing governments to collect mitigation fees has very strict requirements for what it can be used to pay for, all based on the premise that the need for the expenditure being approved must have been cause by the development or payer of the fee. The only reasonable justification for Station 8 is the MOU with the Casino. The vast majority of the mitigation funds were collected from areas having no impact at all on the casino area.

No other rural area of the county has stations placed less than eight miles apart, in this case Coarsegold station is less than eight miles from YLP station. How did they possibly justify building another station between them?

have the seasoning right. Take about a tablespoon of your mix, and pat it out and fry it like a mini hamburger. If it tastes right, it's a go; if not, adjust your seasoning. Another thing I have learned from the internet is don't overwork your hamburger. Only mix it just enough to get everything combined, because if you over work ground beef, it will be tough.

My brother Lloyd used to bring me things to cook. He is the one that introduced me to lamb shanks. He came in with those things and I thought, "How in the world do I cook them?" I found a recipe and they were delicious! Well, one day he asks me to make a meatloaf using the recipe that someone from his work had brought for a potluck. He said it had sauerkraut and Swiss cheese in it. I said, "Lloyd, you are crazy!" But he talked me into it. I love a Reuben Sandwich, so how far could I be going wrong? I made my basic recipe for meatloaf using 3 pounds of hamburger. I put half the mix in the bottom of a 9 x 13 baking pan. Drained well a jar of sauerkraut and spread it on the meatloaf then placed sliced Swiss cheese (the real cheese, not the sliced processed cheese) on top of the sauerkraut, then added the rest of the meatloaf mix. The original recipe called for Russian Dressing on top of the cheese, but I didn't think we'd like that. Before I put it in the oven I spread it with a mixture of catsup, sugar, a dash of vinegar and a dash of Worcestershire sauce. I baked it for about an hour in a 350 oven

and it was wonderful. For a smaller portion, adjust the size of your meatloaf and use a can of kraut, unless you have other uses for left-over kraut if you use the jar.

For Atkins Fans

For those of you that are watching your carbs, I found a recipe for you:

LOW CARB MEATLOAF

- 1 C chopped fresh spinach
- 2 pounds ground chuck
- 1 C chopped tomato
- 4 oz Blue Cheese (or Feta)
- 2 scallions minced fine
- 1 tsp dried thyme
- Salt and Pepper to taste

Mix all ingredients together in a large bowl. Divide mix in six equal parts. Place each part in an ungreased six cup muffin pan. Bake at 350 until internal temp in 160 degrees. Let cool 5 minutes in pan before removing to serving platter or let cool completely to wrap for the freezer.

My mom usually fixed creamed peas or peas and carrots for a side dish and she would fix what I called broasted potatoes every time she made meatloaf. For the potatoes, wash well the number of potatoes you need for your family and cut them in quarters lengthways. Boil in salted water until not quite done. Drain them well, and place on a baking sheet and put melted butter on them and bake in the oven until golden.

No matter how you make your meatloaf, be sure to keep the leftover for sandwiches the next day.


